BEFORE THE HONOURABLE ACTING JUDGE RANDERA

PLEASE NOTE THAT THE PRESIDING JUDGE HAS DIRECTED AS FOLLOWS:

1. Practice Notes and/or heads of argument must be e-mailed in word version in matters allocated to Randera AJ to ZTwaku@judiciary.org.za and ingatwaku@gmail.com in all matters by all the parties as soon as possible but no later than 13h00 on Monday, 01 August 2022.
2. All matters set down for 02 August 2022 will be called on Tuesday (02/08/2022) at 10h00 by Randera AJ. All counsel must attend roll call unless excused.
3. In terms of paragraph 18 of Chapter 9.23 of the Gauteng Local Division Johannesburg Practice Manual dated October 2018 (*'the High Court Practice Manual'*) read with paragraph 183 of the Judge President's Revised Consolidated Directive of 18 September 2020 (*'the Revised Consolidated Directive'*), the relevant papers were to have been filed by 12h00 on 29 July 2022. All files were frozen at 12h00 on 29 July 2022.
4. The reason for freezing the files is to ensure compliance with paragraph 18 of Chapter 9.23 of the High Court Practice Manual and to have control over the documents presented for filing after the cut-off date. Should parties wish to file further papers before the hearing date they are to seek the permission of the Judge via their registrar who will, after the permission is granted, unfreeze the file to permit the

uploading of the further documentation. (This permission will only extend to the uploading of the documents and not also to the receipt of the additional material as evidence which feature will still have to be canvassed at the hearing). Any party breaching this procedure may be visited with a punitive costs order for such transgression.

5. Legal representatives are to access their Caselines/ Court online files and are to ensure that a complete set of papers has been uploaded. If the papers are incomplete, the procedure set out in paragraph 4 hereof is to be followed.
6. Attention is drawn to matters where documents have not been uploaded. Unless contact is made with Acting Judge Randerer's registrar by no later than 10h00 on Saturday, 30 July 2022 to remedy the situation, these matters will be removed.
7. The Judge may communicate with the parties' representatives via widely shared notes posted on the electronic file. Legal Representatives are to look out for these communications and are requested to respond to such communications.
8. Strict compliance with paragraph 6 of the Revised Consolidated Directive will be demanded. Should such affidavits not have been filed by 12h00 on 29 July 2022, the procedure set out in paragraph 4 hereof is to be followed.
9. The hearing of all Urgent Applications (both opposed and unopposed) will be conducted in Open Court (Court 9F), and all Counsel must present themselves for Introductions at Chambers on the twelfth floor (Chambers 1204) at 09h45.
